Wake Me Up Lord


Wake me up Lord, so that the evil of racism finds no home within me.

The two Mobile Soup Bus Kitchens are renovated school buses with small kitchenettes and running water that go out into neighborhoods to feed the hungry! Both Soup Buses have 6 tables each and the capacity to seat 24 people at a time.



This ministry feeds an average of 80 people per night and serves more than 17,000 hot meals each year. The bus is staffed with crews made up of volunteers who prepare and bring the meals on the Bus four nights a week!






SYSTEMATIC RACISM



DEFINITIONS


Racism

 prejudice, discrimination, or antagonism directed against a person or people based on their membership in a racial or ethnic group, typically one that is a minority or marginalized.

Systemic Racism

• a form of racism expressed in the practice of social and **political institutions**. It is reflected in disparities regarding wealth, income, criminal justice, employment, housing, health care, political power and education, among other factors.

13th Amendment



- Section 1.
- Neither slavery nor involuntary servitude, except as a punishment for crime whereof the party shall have been duly convicted, shall exist within the United States, or any place subject to their jurisdiction.
- Section 2.
- Congress shall have power to enforce this article by appropriate legislation.

The War on Drugs

(synonymous with African Americans as War on the black man, family, and the community)




Policies- 1971

- Richard M. Nixon signed the Controlled Substances Act (CSA) into law in 1970. This statute calls for the regulation of certain drugs and substances.
- **Nixon** went on to create the Drug Enforcement Administration (DEA) in 1973. This agency is a special police force committed to targeting illegal drug use and smuggling in the United States.
- At the start, the DEA was given 1,470 special agents and a budget of less than \$75 million. Today, the agency has nearly 5,000 agents and a budget of \$2.03 billion.
- Target Groups- Anti war protesters and African American citizens


Criminalization of African Americans

 Ronald Regan's presidency was almost deemed as a continuation. He fed off Nixon and fed off the fear of blacks as "criminals." This continually fed the <u>prison industrial</u> <u>complex</u> as the population increased.



Criminalization of African Americans cont.

- During Bill Clinton's presidency, not only did he continue the "war on drugs," but he created the crime bill and mandatory minimums. Once again, this goes back to more policy disproportionally affecting blacks. Yield offenses often lead to blacks being forced into a plea deal (minimum sentencing) or run the risk of being overcharged.
- Black nuclear families have been torn apart since the days of slavery



Fatherlessness



- Children are four-times more likely to be poor if the father is not around. And we know that poverty is heavily associated with academic success. [Fatherless kids] are also twice as likely to drop out of school.
- Youths in father-absent households have significantly higher odds of incarceration.
- Also, Consider the Pruitt-Igoe housing complex (1956-1976) in St. Louis, Mo. By policy, in this housing project, homes were allotted to families under the condition that men could not be present around during the workday. This resulted in fathers, often unemployed, having to hide in the closet. Eventually they would just stop showing up.

Racial Disparity in the Judicial System

Consequences of the War on Drugs

Public support for the war on drugs has waned in recent decades. Some Americans and policymakers feel the campaign has been ineffective or has led to racial divide.

Between 2009 and 2013, some **40 states** took steps to soften their drug laws, lowering penalties and shortening mandatory minimum sentences, according to the <u>Pew</u> Research Center.

When people are released from jail or prison, they are hoping for a second chance. But they face more than **48,000** separate restrictions, known as collateral consequences.

African Americans are up to 10 times more likely than whites to be stopped, arrested, and sentenced. They are also up to 10 times more likely to face these restrictions.
