A MESSAGE FROM CFO KEVIN PRIOR ON 1099s

Anyone who has worked with 1099s is familiar with the \$600 annual limit per payee that triggers the need to generate one. This limit has been the same for a very long time (decades). Some good news – this limit, effective for payments made January 1, 2026 and forward, has been raised to \$2,000, and this limit will be “indexed” each year for inflation.

What does this mean for SVdP? This will certainly reduce the number of 1099s that need to be issued each year and, for some Conferences and smaller Councils, may eliminate the vast majority of these required forms.

Note: the IRS updated instructions are not yet published (last revision is from April 2025). We will post them on our website as soon as available.

As always, good recordkeeping is still very important.
